Built in 1910, the Cumbres & Toltec Scenic Railroad is the finest and most spectacular example of steam era, narrow gauge mountain railroading in North America. It is located in a lush forest, corner of the majestic Rocky Mountains along the border between Colorado, New Mexico and Arizona, Colorado. Today, its steam locomotives host 94 miles of rail that take you from the Denver & Rio Grande Western Railway, carrying visitors over high bridges, through tunnels, and along across steams above stunning vistas.

The Friends of the Cumbres & Toltec Scenic Railroad, Inc. (FCTSR) is a 501 (c) 3 nonprofit organization. Established in 1981 and incorporated in 1989, FCTSR is an organization of FTRM members from across the United States and several countries oversees FCTSR and Cumbres & Toltec Scenic Railroad Committee work together in proactive and accepted the railroad and support its operations for the people of Colorado and New Mexico who visit, and the time of thousands of visitors and future generations.

**THE BUSINESS CHALLENGE**

To manage its fixed accounting, fundraising and membership management, FCTSR was using a well known online accounting software package, however they needed a more robust solution.

FCTSR need to restructure their current accounting software to accommodate their fund allocation needs, but they could see that the process would only become more complex in the future. In addition to fulfilling their allocation needs, they wanted a system that was user friendly and would help streamline their reporting capabilities.

"We really needed a solution that specifically handled fund accounting," explained Kathleen Rice, bookkeeper for the Friends of the Cumbres & Toltec Scenic Railroad, Inc. "We had income and expense that belonged in more than one 'fund' in the software. A member/donor would report that a specific amount go to a specific project, so we had started using the classes in the system for our major projects. However, because we had multiple funds supporting one project in addition to capital campaigns, the process became very complex. We needed a system that would recognize that one or multiple funds could support one or multiple projects."

Phantom and CRM challenges paired with program tracking, membership reporting and the overall need to track data FCTSR wanted to be able to track and record split gifts. They needed their CRM system to record what people were buying at what time and also have the ability to provide membership reporting quickly and easily. By centralizing data about donors and members, their goal was to be able to remove primary record to one database and know all the ways they had contributed to their organization.
